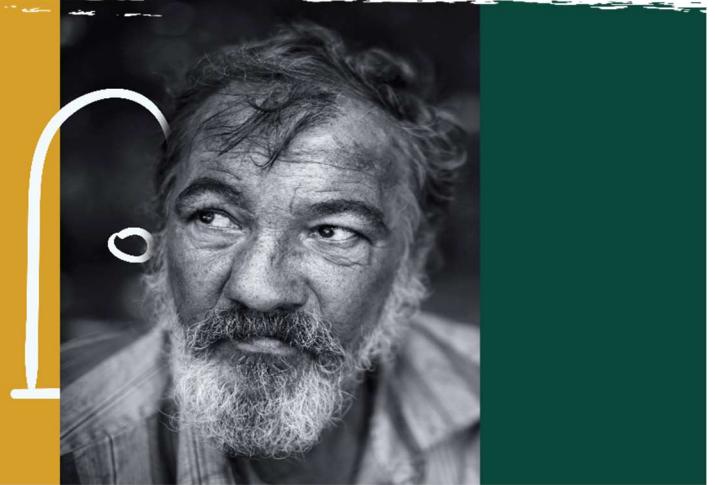


Neighborhood Assistance Program Tax Credits



Your Meaningful Gift to Support Columbia's Neighbors Experiencing Homelessness Provides Your Company 50% in Tax Credits (limited time only)

Missouri's Neighborhood Assistance Program (NAP) allows its residents to determine how their state tax dollars will be spent through their charitable donations. The Voluntary Action Center (VAC) is approved to offer \$249,998 in NAP tax credits to donors who support The Opportunity Campus, bringing together organizations from across Columbia to reach a common goal and empower people to **Make Home Happen**.

When you make a qualifying gift of \$5,000 or more to The Opportunity Campus, VAC can offer tax credits equaling 50% of the total gift amount. This credit combines with your federal and state charitable income tax deduction to lower the net cost of your donation. We encourage you to take advantage of these tax credits now. They will go fast!

Tax Benefit Example:

Donation Amount	\$25,000	\$50,000	\$75,000	\$100,000
Missouri Tax Credit (50%)	\$12,500	\$25,000	\$37,500	\$50,000
Federal Charitable Deduction Based on 35% Tax Bracket	\$4,375	\$8,750	\$13,125	\$17,500
MO Charitable Tax Deduction (based on 6% State Tax Bracket)	\$1,500	\$3,000	\$4,500	\$6,000
Your Net Cost (estimated)	\$6,625	\$13,250	\$19,875	\$26,500
Total Benefit to The Opportunity Campus	\$25,000	\$50,000	\$75,000	\$100,000

Eligibility

Individuals or businesses with Missouri business income:

INDIVIDUAL DONOR

- Operating a Farm
- Operating a Sole Proprietorship
- Rental Property or Royalties
- Partnership, S-Corporation, or Limited Liability Corporation

BUSINESS DONOR

- Corporation
- Financial Institution
- Partnership
- S-Corporation
- Limited Liability Corporation
- Insurance company

Next Steps

1. Make your contribution via cash, check, or stock to the Voluntary Action Center (VAC) and indicate your desire to apply for tax credits.
2. We will send you an acknowledgement and brief instructions on completing the NAP Tax Credit application.
3. Complete and return the [notarized NAP form](#) with proper documentation to VAC.
4. VAC will submit the application and proof of donation to the Missouri Department of Economic Development.
5. You will receive a NAP certification letter via email from VAC.
